Sub: Intimation about resignation of Independent Directors

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that Mr. Pradip Dubhashi and Mr. Ramnath Pradeep, both Non-Executive and Independent Directors of the Company, have submitted their resignation with effect from 21st June, 2021.

In his resignation letter Mr. Dubhashi has suggested that, given the current business conditions of the Company, the Board of Directors shall meet frequently in person, which on account of his residence at Pune, he won't be able to attend the Meetings and therefore he has decided to resign from the Directorship of the Company.

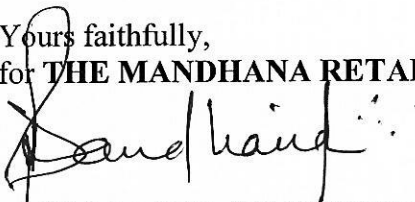

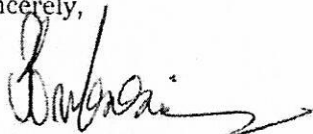

Kindly acknowledge the receipt of this letter and give immediate effect to the 'resignation'.

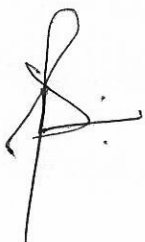

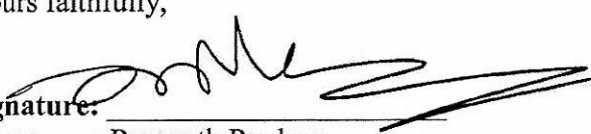
I express that it was my privilege to have served the Board of the Company and wish the Company all the success in the future. My association with the Company as an independent director was rewarding and fruitful.
